ORDINANCE No. 7

(As amended up to 16-10-1985)

Admission of Students to a College, University Teaching Department or School of Studies, Transfer of Students and Maintenance of Discipline

(Refer Clauses i, viii & xvii of Section 37)

- 1. In this Ordinance, unless there is anything repugnant in the subject or context:
- (a) "equivalent examination" means and examination which has been conducted by:
- (i) any recognized Board of Higher Secondary Education, or
- (ii) any Indian University other than this University incorporated by any law in force for the time being, and recognized by the University as equivalent to its corresponding examination or the final examination held under the C.G. Madhyamik Shiksha Adhiniyam, 1965 as the case may be.
- (b) "qualifying examination" means an examination the passing of which makes a student eligible for admission to a particular year in a course of study leading to a Bachelor's or post-graduate degree of diploma conferrable by this University.
- 2. Admission to all-courses except Engineering, Medicine and Ayurved shall be governed by the principles:
 - Admission shall not be matter of right, (i)
 - (ii) Eligibility shall not imply admission.

- (iii) Admissions in all Institutions affiliated to the University shall be governed as per Regulations made in this behalf.
- 3. A students seeking admission to a College, University Teaching Department or School of Studies (hereinafter called an Institution) shall, on or before the date prescribed for submission of applications for admission by the Head of the Institution concerned, submit his application on the prescribed form to be obtained from such Institution on payment of the prescribed fee.
 - 4. The application for admission shall among others be accompanied by (i) the School or College Leaving Certificate signed by the Head of the Institution last attended by the Students, (ii) true copy of the statement of marks showing that the applicant has passed the qualifying examination, and in the case a student who

passed the examination as private candidate, a certificate signed by two responsible persons certifying to the good character of the applicant. If an applicant for admission, as aforesaid, has passed the qualifying examination from a Board other than the Board of Secondary Education, Madhya Pradesh, or a University other than this University, he shall submit in addition to the School or College Leaving Certificate, and eligibility or a Migration Certificate from the Registrar of such Board or University, as the case may be together with immigration fee of rupees thirty.

Provided that if it does not become possible for the applicant to obtain a migration certificate in time for making the application, he may make the application in time stating that the certificate shall be produced as soon as received for that purpose he may be allowed such time as the University may specify.

Provided also that no immigration fee shall be payable by a student migrating from any statutory University in Chhattisgarh or a Statutory Board of Secondary Education or Intermediate Education in Chhattisgarli

- 5. (1) No student shall be admitted to an institution for pursuing a course of study for the initial year of the first Degree under any Faculty unless he has passed the final examination held under the Chhattisgarh Madhyamik, Shiksha Adhiniyam 1965 (23 of 1965), or an examination declared equivalent to such examination by the University or such other qualifying examination as may be prescribed from time to time.
- (2) No student enrolled in the University shall be admitted to any subsequent higher class in any institution unless he has passed the examination qualifying him to appear for the examination for which he will be preparing.

THE RESIDENCE TO SECURITY OF THE PERSON OF T

Provided that student who is eligible to appear at a Supplementary or Second Examination may be provisionally admitted to a subsequent higher class but if he is not declared successful at such examination, his admission to the college/institution will be cancelled.

- (3) No student migrating from any other University shall be admitted to any class institution unless he has passed the examination which has been declared by the University as equivalent to the qualifying examination for a student of the University.
- (4) Without prejudice to the provision contained in sub-clause (3) above, no student migrating form any other University shall be admitted to any class in an institution without the previous permission of the Executive Council wherever by any general or special direction, such permission is necessary.
- (5) An applicant for admission to a course leading to a Bachelor's degree shall not be so admitted unless he is prepared to appear in all the subjects prescribed for the particular degree examination.

- (1) No student who has passed a part of any degree or post-graduate examination form another University shall be admitted to subsequent higher class for such examination in any institution without the approval of the Kulapati in consultation with the Dean of the Faculty in case of degree examination and the Chairman of the concerned Board of Studies in case of post-graduate examination.
- No person who is under sentence of rustication from another University or (2)a Teaching Institution connected with that University shall be admitted to any course of study in any Institution maintained by or affiliated to this University.
- Admission of students to all institutions except those for Ayurveda, Engineering and Medicine in each academic year shall be completed by the first day of the academic concerned.

* Provided that the Head of an institution may, in his discretion, admit a student to the institution in 31st July and for special reasons with the permission of the Kulapati upto 45 days from the date of commencement of the academic session.

Provided where 31st July or 14th August is a holiday, the next working day will be the last date in such case. In institution for Ayurveda, Engineering and Medicine, corresponding last date of admission shall be 21st August and 31st August.

Provided that a student who is eligible for second or supplementary examination of the University shall be permitted to take provisional admission to the next higher class within the date prescribed 4 . The second above. If he/she fails to clear the supplementary or pass the second examination the provisional admission in the higher class shall stand as cancelled.

Provided further that the Kulapati shall have powers to grant admission in cases of candidates (i) who qualify for admission as a result of revaluation and who seek admission within 21 days from the date of declaration of the result, (ii) Candidates coming on transfer from other admission as given above on the clear understanding that the attendance of all such students admitted under the provision shall be counted from the date of commencement of the session."

(ii) A complete list of all student admitted to the Institution up to 31st July shall be forwarded by the Head of the Institution to the Registrar of the University by the 7th August with a certificate that all admissions have been made as per University rules and that no exception has been made. College of Engineering, Ayurved and Medicine shall forward such lists by the second Monday in September.

- (1) A student shall be enrolled as a member of an institution as soon as he is admitted by the Head of the institution and has paid the prescribed fees.
 - (2) A student seeking admission to an institution after the commencement of the session shall require to pay tuition fees form July of the year unless he migrates from another institution in the University and has paid his fees in the former institution up to the proceeding month.
- 9. The Head of the Institution may permit a student to change his optional subjects for a course or with the approval of the Kulapati, to change the Faculty till 31st August. No change thereafter shall be permitted.
- 10. No student shall be allowed to migrate form one institution to another under the jurisdiction of this University without a Transfer Certificate and no transfer from one such institution to another shall in any case be permitted after the date on which the application of a student for admission to the ensuring examination has been forwarded to the University.
- 11. (1) Subject to the provision contained in para 10 a student, who during and academic session desires to leave the institution of which he has become a member shall give notice in writing to the Head of the Institution of his intention to leave stating reasons therefore and further stating the name of the institution, if any, which he which he wishes to join. If the change is to another Institution in the same city, the Head of the Institution shall consider the reasons given to justify such a change. If they are strong enough to justify such a change, he may pass orders accordingly.
- (2) On such orders being passed, the student in question shall:

- make payment of all fees due to the Institution up to the month of the application for the transfer certificate; and
- (ii) refund whatever, if any, scholarship or studentship has been paid to him from the funds of the Institution, if required by the Head of the Institution to do so.
- (3) When the student has made all the aforesaid payments, the Head of the Institution shall issued a transfer certificate.
- 12. A student migrating from one Institution to another under the jurisdiction of the University shall not be required to pay such installment of tuition fees as he has already paid in the Institution from which he is migrating.
- An appeal can be preferred before the state Government against the order of the Head of the Institution and decision of the state Government there upon shall be final.
 - 14. (1) When a student has been guilty of breach of discipline, within or outside the premise of the University or an Institution, or persistent idleness or has



been guilty of misconduct, the Head of the Institution at which such student is studying, Kulapati/Registrar/Dean Student Welfare may according to the nature and gravity of the offence.

- suspend such a student from attending classes for not more than a week at a time; or
- (b) expel such a student from his institution;
- disqualify such student from appearing at the next ensuing examination; or
- (d) rusticate such a student.
- (2) Before inflicting any punishment as aforesaid the Head of the institution shall give the student concerned an opportunity of personal hearing and record the reasons of inflicting the punishment in writing.
- (3) The Head of the Institution concerned shall have power to suspend for such time as may be necessary a student temporarily form the Institution pending inquiry into his conduct in connection with unalleged offence.
- (4) The period, during which a student remains suspended for completion of any Inquiry shall be reckoned in the calculation of his attendance for appearing at an examination provided he is found innocent.
- (5) A student who has been rusticated shall not be admitted to another Institution within the jurisdiction of this University. Ordinarily, the period of rustication shall not exceed two years. Other Universities shall be informed of the fact of the rustication.
- (6) The rustication of a student from an Institution shall entail the removal of his name form the register of enrolled students.
- There shall be a Proctorial Board whose constitution/ powers duties shall be such as may be prescribed by Regulations.
- Regulations. It shall be compulsory for all students as may be prescribed by Regulations. It shall be compulsory for all students to comply with its provisions. In the event of non-observance of the Code, by a student, it shall be the duty of the Principal of the College/ Head of U.T.D./ Registrar of the University to take disciplinary action against him under paragraph 14 above.

ORDINANCE No. 8

ENROLMENT OF STUDENTS AND THEIR ADMISSION TO COURSES OF STUDY

[Refer clause (i) of section 37]

- Any person, who shall have passed the Higher Secondary School Certificate
 Examination of the Board of Secondary Education, Chhattisgarh or an examination recognised by the University as equivalent to it, may be enrolled as a student of the University.
- Application for enrolment as a student of the University shall be made to the Registrar

 in the prescribed form and it shall be accompanied by an enrolment fee of rupees five.

 Such application shall be submitted through the Principal of the College to which the student has been admitted.
 - 3. (i) No student shall be deemed to have been admitted to any course of study as a regular student of the University unless his name is borne on the register of enrolled students.
- prescribed for admission to the course of study concerned, the fee for enrolment paid by a student shall not be refunded under any circumstances.
 - 4. The procedure for submission of applications for enrolment of students by colleges shall be as follows, viz:-
- (i) All application forms from students shall, together with the necessary fees, migration certificate, if necessary, and returns on the prescribed forms reach the University Registrar by 30th September of the academic year in which the students are admitted.
 - (ii) On payment of a late fee of rupees ten, the Kulpati may, for special reasons to be recorded, permit the enrolment of a student whose application form, enrolment fee or the migration certificate have been submitted after the due date and if the Kulapati is satisfied that the delay in submission is not due to any lack of diligence on the part of the student, he may sanction remission of the late fee.

- (iii) In the case of all students who apply for enrolment the Principal of the college shall send to the University a general certificate to the effect that he has inspected the certificate issued by the appropriate authorities and satisfied himself that in each case the student concerned has passed the examination which under the rules of the University entitles him to join the course to which he has been admitted in the college.
- No person, who is under sentence or expulsion or rustication from another University shall be admitted to any course of study during the period for which the sentence is in operation.
- 6 (i) A student who is enrolled in the University may apply for a change, correction or alteration in one's own name or surname to the Registrar of the University with a fee of Rs. 20/-
- (ii) The Registrar, if he is satisfied with the reasonableness of the request, may pass order for the change or correction of the name of the student.
- (iii) Any change, addition or modification, shall be recorded in the University

 Register in red ink under the attestation of the Registrar and a certificate to that effect shall be issued to the applicant.
- (iv) Under no circumstances shall any alteration be made in the University certificate, diploma, degree and other document issued in favour of the applicant prior to the order for a change or correction in the name.
- (v) In all subsequent documents, certificates, diplomas and degrees of the
 University the former as well as new name shall be entered and all
 correspondence shall be carried on in like manner.
 - (vi) The application for change or correction in the name shall be made either through the Head of the Institution where the student is studying or in case of others shall be countersigned by two members of the Court or a First Class Magistrate and shall be supported by an affidavit.
 - (vii) The fee deposited with the application shall not be refunded to the student unless his application is rejected.

ORDINANCE No. 9

THE CONDITIONS OF THE AWARD OF FELLOWSHIPS AND SCHOLARSHIPS

(Refer clause (vii) of section 37)

- (a) Every year in the month of July the University shall invite applications through an advertisement in the news papers for the awards to be made.
 - (b) All awards of Fellowships, Research Scholarships and other Scholarships shall be made on the recommendation of a committee consisting of:-
 - (i) The Kulapati

Chairman

- (ii) Three Deans of Faculties appointed by the Executive Council every year.
- (iii) The Registrar

Member Secretary

- 2. Subject to the general conditions applicable to all fellowships and research scholarships as laid down in paragraph 4 below the value duration and conditions of award of University Grants Commission Fellowships shall be such as are laid down by the University Grants Commission.
 - 3. The value and duration of Research Scholarships instituted by the University shall be laid down by the Executive council in consultation with the Academic Council.
 - 4. The award of fellowships and research scholarships shall be made subject to the following conditions:
 - The fellow/scholar will do whole-time research work under an approved guide on a subject approved by the University.
 - (ii) The fellow/scholar shall not accept or hold any appointment paid or otherwise or receive any emolument, salary, stipend, etc. from any other source during the tenure of the award nor shall be engage himself in any profession or trade during that period. He may, however, undertake teaching assignment of not more than nine hours a week in the institution, where he is working without accepting any remuneration.
 - (iii) The fellow/scholar shall not join any other course of study or appear in any examination after commencing work under the fellowship/scholarship.

Provided that the Kulapati may, on the recommendation of the guide, permit the Fellow/Scholar to join a Language diploma course and appear in an examination there for.

Provided further that exemption could be provided for those also who wish to appear in an examination or a subject relevant to the problem of research without supplicating for a degree.

- (iv) Unless permitted by the guide to work for a specified period at some other place the fellow/scholar shall be required to attend the institution, where he is to work, on all working days.
- (v) If any information submitted by the fellow/scholar in his application is found to be incorrect, incomplete or misleading, the award may be terminated by the Executive Council after giving him an opportunity of being heard.
- (vi) If at any time it should appear to the University that the progress or conduct of the tellow/scholar has not been satisfactory, the fellowship/scholarship may be suspended or withdrawn.
- (vii) (a) Leave for a maximum of thirty days in a year in addition to general holidays may be taken by a fellow/scholar with the approval of the guide and the University. The general holidays, however, do not include the vacation period e.g. summer, Dussehra, Dewali, X-mas vacations. No other leave with Fellowship/Scholarship shall be admissible.
 - (b) The fellow/scholar may, in special case, be allowed by the University leave without fellowship/scholarship for a period not exceeding three months during the tenure of the award on the recommendation of the guide.
 - (viii) The fellow/scholar shall be required to pay the fees prescribed by the institution where he works.
 - Post-graduate scholarship instituted by the University shall ordinarily be tenable for two academic session i.e. twelve months in the first year and ten months in the second year on condition that the scholarship holder produces a certificate of efficiency in studies from the Head of the Department in the subject of study or the Principal of the College.

- If two or more candidates are eligible for the award of the last scholarship, the scholarship shall be divided equally between the candidates concerned.
- The scholarship shall be tenable from the 1st of July if the scholarship holder joins the college within one month of the date of the opening of the college after the summer vacation and pays the tuition fee from the commencement of the session. In any other case, it shall be tenable from the date on which the candidate joins the college.
- The payment of scholarships shall be made only on receipt of scholar's receipted bills 8, duly countersigned by the Head of the institution where he studies. No scholarship shall be drawn for a month unless the scholarship holder has attended the institution regularly in that month.
 - The drawl of scholarship shall be done in accordance with the procedure that may be laid down by the University.
- 10. A scholarship-holder shall not combine any other course of study with the course for which the award is made.
 - A scholarship shall be cancelled in the Final year if the scholarship-holder fails to secure at last 50% marks in the Previous Examination of the concerned Master's degree of Arts, Science, Life Science, Social Science and Commerce and 60% in other Faculties.
- If a scholarship-holder is unable to appear at the previous examination on account of 12. sickness or any other reasonable cause, the scholarship for the months of March and the firm it a street mann April shall be paid only if the Head of the institution certifies that the scholar fix Born of the order diligently studied for the examination, but was unable to take the examination for The second second reasons beyond control. Such a scholar shall not receive scholarship during the next e solve i disam session, but shall be entitled to the scholarship during the studies for the Final THE RESIDENCE OF THE RESIDENCE examination, if the scholar passes the Previous Examination with the requisite standard in the succeeding year in the first attempt.

- A scholarship-holder shall at all times be of good behaviour and observe all rules of discipline.
- 14. (1) A scholarship shall be liable to termination. if:
 - The scholarship holder discontinues studies during the middle of a session; or

- (ii) the scholarship-holder, after he has been given a reasonable opportunity to explain his conduct, is in the opinion of the Executive Council guilty of a breach of para 13 of this Ordinance, and if the Executive Council so directs, the scholarship-holder shall also be liable to refund the amount of scholarship drawn by him.
- (2) The order of termination passed by the Executive Council shall be final.

ORDINANCE No. - 10

TRAVELLING ALLOWANCE AND DALY ALLOWANCE (Refer clause xx of Section -37)

Traveling Allowance and Daily Allowance to members (other than local members) of
the authorities, bodies and committees of the University, Moderators, Examiners,
Inspectors, appointed to Inspect the Colleges or Centers of Examination shall be as per
Government Rules in Vogue.

'Members other than Local Members of the Authorities' Bodies and Committees of the University, Moderators, Examiners, Inspectors appointed to inspect colleges or centers of examinations shall be paid traveling allowance and daily allowance as per State Government Rules for attending meetings or for journeys connected with examinations or the affairs of the University.

Examiners conducting the practical/Viva-Voce Examination should submit their T.A.

Bills through the superintendent/ Principal of the Examination Centre concerned who will forward the same to the University Office duly certified in the following form:

Officers of the University if the meeting is held on holiday or they are deputed to
attend the meeting at a place outside University premises.

3. Traveling Allowance and daily allowance shall be admissible in case of the Kulapati, the officers and other employees of the University in accordance with rates prescribed

- from time to time by the Government of Chhattisgarh for its employees in similar pay range or class.
- For halts beyond ten days at one place, daily allowance shall be admissible at half the normal rate after ten full daily allowances are earned.
 Provided that in case of an employee of the University full daily allowance for the
 - period exceeding ten days shall be admissible for halt at one place if such halt for important University work is permitted by the Kulapati.
- 5. Delegates or representatives of the University attending an academic conference congress shall be paid traveling allowance at the rate of single first class fare each way plus daily allowance for not exceeding three days in all at the rate of Rs. 15/- per day of business.

The officers and employees of the University shall be entitles to receive aemal hotel charges in addition to T.A. and D.A. for the journeys undertaken by them in the State and out side the State as indicated below:

MASTER OF BUSINESS ADMINISTRATION

- This degree shall be known as Master of Business Administration (MRA).
 - (a) The duration of this course for Full Time course of study shall extend over two full academic sessions and each of these academic sessions shall be subdivided into two semesters each.

Provided that the following examinations shall not be taken as basic degree for application for admission to MBA course:

- 6. The students admitted to MBA course shall not be permitted to appear at any other examination

 - (b) Such in-plant training as may be prescribed by the University,
 - (c) Such factory visits as may be prescribed by the University.
- There shall be a University Examination conducted by the University at the end of each
 semester on the basis of course contents and scheme of examination as may be prescribed
 by the University from time to time.
- 9. A student after having prosecuted a regular course of study in either Full time or Part time course of study in the University as prescribed by the University shall be eligible to be admitted to the semester examination if he/she had attended at least 75 percent of the classes of the semester concerned.
- 10. A candidate in order to be declared pass at any of the semester examination shall be required to obtain at least 40 percent marks in each of the theory papers and 50 percent marks in the aggregate of theory papers; 50 percent marks in internal assessment and project report separately.
- 11. A candidate declared pass at the First Semester examination shall be eligible to be promoted to the Second Semester and shall be eligible to take up the Second Semester examination if he/she fulfils all other conditions to be eligible to appear at the examination.

Provided that if a candidate after passing in the Internal Assessment of all the papers and appearing in all the theory papers of the First semester examination, fails in any One or Two or Three theory paper(s) at the First semester examination, but secures at least 48% marks in aggregate in the papers cleared at the First semester examination, he/she shall be allowed to keep the term (ATKT) and shall be eligible to be promoted to the second semester. In this case, the same student is required to take up the examination of ATKT paper(s) in which he/she had failed with the subsequent first semester examination.

Provided that if a candidate after passing in the Internal Assessment of all the papers and appearing in all the theory papers of the second semester examination, fails in any One or Two or Three theory paper(s) at the second semester examination, but secures at least 48% marks in aggregate in the papers cleared at the second semester examination, he/she shall be allowed to keep the term (ATKT) and shall be eligible to be promoted to the second semester. In this case, the same student is required to take up the examination of ATKT paper(s) in which he/she had failed with the subsequent second semester examination.

Maximum three chances for clearing the ATKT paper will be given to the candidates failed in the theory papers.

permission of the Professor and the Head of Department of
his Institution, while a private candidate will have to secure
the prior permission in writing of anyone of the Professors of
the subject working in an institution within the jurisdiction of
the University and will work under supervision of that
Professor after obtaining prior permission of the University to
that effect.

6. A candidate who has passed the M. A. Examination of the University in any subject shall be allowed to present himself for the M.A. Examination in anyone or more of the optional papers in tha1 subject not taken by him at the said examination and is successful will be given a certificate to that effect.

No Candidate shall be allowed to offer more than two additional papers in any one year.

7. For both the Previous and Final Examination a candidate will be declared successful If he/she obtains at least 36% of the aggregate marks in the, subject. In subject, in which both Theory and Practical Examinations are held the examinee must pass separately- in the Practical Examination obtaining not less than 36% marks.

No division will be assigned on the result of the Previous Examination, The division in which a candidate is placed shall be determined on the basis of aggregate of marks obtained in both the M. A. Previous and, the M.A. Final

Examination.

RECEIVE

Successful candidate who obtain 60% or more of the aggregate marks shall be placed in the First Division, those obtaining less than 60% but not less than 48% in the Second. Division and all other successful candidates obtaining less than 48% in the Third Division.

10. Candidates who have passed .the M.A. Examination of the University in any, subject in Third or Second Division and desire to appear at the M.A. Examination in the same subject for improving division without attending a regular course of study in a college affiliated to the University or in a teaching Department of the University be allowed to appear at the aforesaid examination as non-collegiate student on the following Conditions:-

(i) There shall be only two Divisions for such candidates the First Division and Second Division. The marks required

for obtaining these divisions shall be

same as prescribed in the Ordinance i. e. examinees who are successful in Final of the Examination and ha.ve obtained 60% or more aggregate of the marks in Previous and Final Examination taken together shall be placed in the First Division and examinees who are successful in Final Examination and have obtained less than 60% but not less than 48% of aggregate marks Previous and Final Examinations taken together shall be placed in the Second Division.

(ii) The result of the candidates obtaining less than 48% of the aggregate marks in Previous and Final of the examination taken together shall not be declared.

(iii) Candidates shall be option to appear at both the Previous and Final Examinations in one and the same year and for being successful at the examination, the candidates shall obtain 48% of the aggregate marks. Provided that such candidates who up to appear in Previous and Final Examinations separately shall have to obtain minimum aggregate required for the Previous Examination but he will have to obtain at least 48% in the aggregate of Previous and Final Examinations taken together or else his result will be cancelled.

(iv) The syllabus for the examination shall be the same as prescribed for the year in which the examination is held.

(v) Not more than two attempts shall be allowed to such a candidate. Failure or non-appearance at the examination after permission has been accorded by the University, shall be counted as an attempt. Provided however such candidates who up to appear at the Previous and Final examination separately will be allowed only one attempt at the previous examination and two attempts at the Final Examination.

(vi) Candidates who wish to avail the opportunity given in foregoing paras will have to apply for permission as required in the Ordinance relating to admission of Non-collegiate students to the. University examinations, alongwith requisite registration fee.

(vii) In case, a student improves his division under provision of this para, the fresh Degree will be issued after canceling his

first Degree.

ALCOHOL: NAME OF THE PARTY OF T

Transitory Provision; The replaced Ordinance relating to Master of Arts Examination shall remain effecting till the examination of 1991, and this new Ordinance shall be Applicable from the examination 1992.
